The general public is further advised that all registered sub-agents are issued with a certificate of registration by the Commission, bearing the Commission's logo, signature of the Superintendent of Insurance, class of insurance business, address and name of the individual or company, registration number and date. The solicitation of insurance business by unregistered sub-agents is a criminal offence and is subject to fines under the <u>Insurance Act</u>.
