The general public is further advised that all registered insurance salespersons are issued with a registration card by the Commission, bearing the Commission’s logo, signature of the Superintendent of Insurance, name and signature of the insurance salesperson, name of company, registration number and expiry date. The list of registered insurance salespersons and their sponsoring company will be available at www.icb.gov.bs.

The solicitation of insurance business by unregistered salespersons is a criminal offence and is subject to fines under the Insurance Act.
