The general public is hereby notified that the persons listed below have been registered during the period 1<sup>st</sup> January, 2018 to 31<sup>st</sup> December, 2018 to carry on insurance business in The Bahamas as insurance salespersons.

The general public is further advised that all registered insurance salespersons are issued with a registration card by the Commission, bearing the Commission’s logo, signature of the Superintendent of Insurance, name and signature of the insurance salesperson, name of company, registration number and expiry date. The solicitation of insurance business by unregistered salespersons is a criminal offence and is subject to fines under the Insurance Act.
